23/06 Minutes from the meeting held on March 1st. 2023.

The minutes of the meeting were approved and signed by the Chairman as a true record.

23/07 Matters Arising:

(a) Wem Road Pavement (22/85(a))

Shropshire Councillor B. Williams had forwarded a report from the Enforcement Officer stating that the matter had not been resolved and legal action would now have to be taken but shortage of staff indicated that this would not be an immediate solution.

(b) Safer Road Partnership 22/93(3a)).

A representative from Sansaw Estates had confirmed that no one from the Estate had spoken to the Enforcement Team and they fully supported them using the current location in the lay-by opposite Harmer Hill Village Hall.

(c) Harmer Hill Reservoir site (92/85(d))

There had been no indication that Shropshire Council had taken the promised legal action to get the site cleared.

(d) Myddle Recreation Ground, Play Area and Woodland Area (92/85(e)).

1. No volunteer had come forward offering to help with the litter collection and it was agreed to look at the possibility of paying someone to do regular collections. A local resident had placed some notices asking people to respect the area but the weather conditions had caused these to deteriorate and it was agreed that the Council should provide some replacements.
2. Mr. Armando Meci had stated that he would repaint the sections of the play area equipment which were deteriorating.
3. Members considered a report on the amount of cycling taking place through the wood, which was causing the main path to break up and damaging the local trees and flora. It was noted that this was a permissive path and cycling was not permitted and it was agreed that notices should be put in place advising the public of the regulations.

(e) Street Lighting (22/93(b2))

Clerk stated that HighLine had been appointed as the contractors for maintaining the Council's streetlights and E.ON had been informed of the decision.

23/08 Correspondence.

Members considered the details of the correspondence received by the Clerk since the last meeting and where appropriate, responses had been or were made.

23/09 Issues arising from the Annual Parish Meeting.

1. Further details relating to the proposed housing development on the playing field in Godings Lane would be considered at the next Council meeting, when a map of the site would be available. It was hoped that the steering group related to this project would be meeting prior to that meeting.
2. The Clerk would ask the new lighting contractor to investigate the possible provision of an additional streetlight in Shotton Lane and for an extension of the 40mph speed limit.
3. Continued efforts would be made to get the speed limit on Wem Road reduced to 30mph rather than the current 40mph.
